FACILITATION AGREEMENT

(A) **GRAYQUEST EDUCATION FINANCE PRIVATE LIMITED**, a company incorporated under the provisions of Companies Act, 2013 (CIN : U65999MH2017PTC293038) and having its registered office at "2nd Floor, Office No. 202, Center Point, Next to Ashoka Towers, Parel, Mumbai, Maharashtra - 400012" hereinafter referred to as "**GrayQuest**" which expression, unless repugnant to the context or meaning thereof, shall mean and include its subsidiaries, successor(s)-in-interest, official liquidators and permitted assigns) of the **First Part**;

AND

(B) **Dr. D Y Patil B School under Dr. D Y Patil Unitech Society**, a Institute approved by AICTE having its registration number as 1-2105683921 dated on 09 - June - 2020, and having its registered office at Dr. D. Y. Patil B-School Bangalore - Mumbai Highway Bypass Rd, Tathawade, Pune-411033 acting through Amol Gawande its director, hereinafter referred to as the "**Client**" (which expression, unless repugnant to the context or meaning thereof, shall mean and include its subsidiaries, successor(s)-in-interest, and permitted assigns) of the **Second Part**;

(GrayQuest and the Client may be individually referred to as a "**Party**" and collectively as the "**Parties**" hereinafter, if the context so requires)

1. FACILITATION SCOPE

- (a) GrayQuest shall offer its Monthly Fee Payment Plans to the Parents in a manner such that the Parents have an option to pay the annual course fees for their children for a given academic year to GrayQuest, in a phased manner as mentioned in **Annexure 1**.
- (b) Should a Parent choose to pay the Annual Course Fees through the Monthly Fee Payment Plans offered by GrayQuest, subject to credit approval, GrayQuest shall pay the entire Annual Course Fees to the Client on behalf of the Parent in two tranche(s) (the entire process, collectively referred to as the "**Facilitation**"). The Annual Course Fees paid by GrayQuest to the Client under this Agreement may be either through its own NBFCs, or through the GrayQuest Channels (further detailed in **Annexure 2**),
- (c) Subject to satisfaction of conditions in sub clause (d) under clause 1, payment of the Annual Course Fees shall be made within a period of 8 *working days* from completion of all loan execution formalities by the parent.
- (d) The liability of GrayQuest to pay the Annual Course Fees on behalf of a successful applicant to the Client shall arise only upon successful approval of grant of loan and execution of all documents and processes for grant of loan, subject to applicable loan terms.
- (e) Client shall not be responsible for any collection of EMIs on behalf of GrayQuest or any kind of transaction between GrayQuest and Parents.

2. TERM

- (a) **Term.** This Agreement shall be effective for a period of 3 (*three*) (*applicable academic*) years from the Execution Date (**Term**). This Agreement may be renewed for a similar term, or such other period as mutually agreed thereafter based on mutual consent by the Parties.

3. MARKETING RESPONSIBILITIES

- (a) Client agrees to display basic marketing materials at each of its branches and locations, which shall include but is not limited to fliers, brochures, banners and standees of GrayQuest and its proposed services.
- (b) Client agrees to provide access and extend support to GrayQuest for enabling appropriate technical ERP integration on its server with the GrayQuest online system. GrayQuest can be displayed as an equal payment option alongside the standard online fee payment options offered by the Client. Client further can have a mechanism that allows Parents/ students to navigate and get redirected to GrayQuest mobile application or website.
- (c) Client shall also share SMS, Email and other online and offline communication regarding GrayQuest with the Parents of the Client institute(s).
- (d) On the Client's prior consent, GrayQuest shall display the logo of the Client as a part of their partnership portfolio - on their website and other marketing materials.

4. FEE REFUND

- (a) During the Term, if any Parent opting for the Monthly Fee Payment Plans offered by GrayQuest, withdraws or disengages themselves and/or their students from the Client, Client shall refund the Annual Course fee paid by GrayQuest in such manner and proportion consistent with the Client's refund policy as mentioned in **Annexure 3**, to GrayQuest.
- (b) If under any circumstances, the client reduces the total annual fee payable parents for the academic year, after disbursement of fees via GrayQuest channels, the client agrees to refund GrayQuest an amount equivalent to the reduction of fee amount compared to the original fee structure.
